**GENERAL INSTRUCTIONS FOR ALL APPLICANTS**

Students who are interested in applying for admission to the California Christian College should request application materials from the Admissions Office. Applications for admission are accepted until the last working day before the first day of scheduled classes. (See current calendar for specific date). Students must complete the application process and be admitted to the college prior to end of the 5<sup>th</sup> working day after classes begin in order to enroll in the current semester. Notification of admission to the college is done for each applicant on an individual basis. Notification of acceptance will be sent as soon as all necessary documents are on file.

**Admission Standards for Audit Students**

A student attending California Christian College is pursuing coursework with a thoroughly Christian educational focus. As such a high standard of commitment and character is expected of CCC students. The audit and non-matriculated student is not enrolled in a degree program. As such, the 2 page application is all that is needed to begin the process. **Note: Audit students do not receive college credit for coursework completed.**
