**Discounts****1. Grade Point Average (GPA)**

- First semester students are not eligible because GPA has not been established
- Any student maintaining a 3.50- 4.00 GPA receives 5% discount on current semester tuition
- Any student maintaining a 2.50-3.49 GPA receives 2.5% discount on current semester tuition

**2. Free Will Baptist Student**

- Member of a CCC-supporting Free Will Baptist Church
- Receive 5% discount on current semester tuition
- Must maintain a cumulative 3.0 grade point average after first semester
- Cannot be combined with Minister Discount

**3. Minister**

- Any credentialed Free Will Baptist minister receives 25% off remaining bill after other gift aid applied.
- Cannot be combined with Free Will Baptist Student Discount.
- Any credentialed non-Free Will Baptist minister receives 20% off remaining bill after other gift aid applied.

**Scholarships**

- **Dr. Mary R. Wisheart Scholarship** from Women Nationally Active for Christ  
One recipient receives a \$1,000 scholarship  
Chosen by the Financial Aid Committee  
**Qualifications:** Free Will Baptist, female, sophomore and above, maintaining a 2.0 GPA
- **GL Johnson Memorial Scholarship**
