FINAL Quarterly Report for HEERF- Emergency Financial Aid Grants to Students

1. *An acknowledgement that the institution signed and returned to the Department the Certification and Agreement and the assurance that the institution has used the applicable amount of funds designated under the CRRSAA and ARP (a)(1) and (a)(4) programs to provide Emergency Financial Aid Grants to Students.*

On May 6th, 2020, California Christian College signed and returned to the Department of Education the Certification and Agreement under Section 18004(a)(1) of the CARES Act. This certification covered the later awards under the CRRSAA and ARP (a)(1) and (a)(4) programs. The institution intends to use, no less than 100 percent of the funds received designated as student portion to provide Emergency Financial Aid Grants to students.

- ARP- \$26,278

6. *The method(s) used by the institution to determine which students receive Emergency Financial Aid Grants and how much they would receive under the CRRSAA and ARP (a)(1) and (a)(4) programs.*

Spring 2020 under CARES- All students were eligible (according to the stipulations then) to receive this grant therefore the institution made the decision to divide the allocation equally to all students. Each student (11 total) received \$562.00 in CARES Act Grant.

Spring 2021, Summer 2021, and Fall 2021- an award schedule was created for awarding in 2021 and beyond:

2021 STUDENT EMERGENCY RELIEF GRANT

This grant is from the student portion of the Higher Education Emergency Relief Fund that was established during the Covid-19 pandemic. With the passing of the CRRSAA (HEERF II), institutions are required to prioritize students with exceptional need. However, students do not need to be eligible for Pell or receive Pell to get this grant. Students may also be enrolled exclusively in distance education (online programs).

Institutions may not (1) condition the receipt of financial aid grants to students on continued or future enrollment in the institution, (2) use the financial aid grants to satisfy a student’s outstanding account balance, unless it has obtained the student’s written (or electronic), affirmative consent, or (3) require such consent as a condition of receipt of or eligibility for the financial aid grant.²

TIMEFRAME

The awards for this grant will use the monies from the student portion of the CRRSAA (HEERF II) and the ARP (HEERF III), allocations/awards of HEERF. These will be awarded each semester. If we still have funds available at the end of 2021, we will extend awards to 2022. If we have funds from the institutional portion not already being used, we may pull from there to award students as well.

WHY THIS AMOUNT?

This formula is based on a fulltime student taking 12 units and receiving full time Pell and FSEOG during 2021-2022 school year.

12 units x \$400= \$4,800, plus fees of \$345 equals \$5,145

Half of Pell for 0 EFC is \$3,248 plus FSEOG of \$400 equals \$3,648

The difference is \$1,497 (5145-3648).

An award of \$2,000 will cover the difference plus give funds for books & supplies.

CENSUS DATES

- Spring 2021- Enrollment for all of Spring 2021 as of 4/26/21 online and 4/28/21 on campus (the end dates for Spring semester)
- Summer 2021- 5/10/2021 online and 5/18/2021 on campus (the published add/drop dates)
- Fall 2021- 9/6/2021 for online and 9/7/2021 for on campus (the published add/drop dates)
- 2022- If awards are available the dates will be the add/drop dates

7. Any instructions, directions, or guidance provided by the institution to students concerning the Emergency Financial Aid Grants.

Spring 2020- All students were sent an email to confirm their mailing address for checks to be mailed. The student needed to reply to the email with their confirmation. The students were also notified in this email that although this grant should be used for costs related to their cost of attendance (food, housing, child care, course materials, etc.) it was not part of their Title IV financial aid package. This grant also would not need to be paid back nor would it impact their school bill.

2021 Students- Students were mailed:

- a letter outlining the award methodologies and their rights and responsibilities
- an award notice listing the amount of the award and waiver option to apply directly to their outstanding balance or current bill first
- an informational cost sheet listing the current semester charges and financial aid

STUDENT RESPONSIBILITY

At California Christian College, the student only needs to submit a 2020-2021 and/or 2021-2022 FAFSA (depending on the semester being awarded). There is no other application required. If the student chooses not to file the FAFSA, an award will be based on the student's enrollment and the 5001+/NA classification on the award schedule.

WAIVER

The student will receive a notice regarding the award with an option to post directly to their account. The student must sign the waiver and initial the box of their choice and return it to the financial aid office before funds will be applied to their account. If they do not return the form, the check will be issued.
